### **Role of General Faculties Council (GFC)**

GFC is responsible for the academic and student affairs of AUArts, subject to the authority of the Board of Governors. GFC acts as the voice of the academic community, providing vision and leadership to the academic community and bringing expertise and academic perspective to the governance of AUArts.

In fulfilling this role, GFC shall promote AUArts' teaching and research consistent with its mandate. GFC makes recommendations to the Board of Governors on academic and student affairs. Furthermore, it provides a forum for the exchange of ideas that inform the development of AUArts' academic plans, policies, procedures, regulations, and practices. GFC supports the tradition established in institutions of higher learning for debate, consultation, and collegiality.

The GFC Steering Committee reconsidered the decision to remove the MS Teams Chat at GFC meetings and provided guidance, which is now contained in the GFC online meeting protocol.

### • GFC meeting format – Fall and Winter 2022

Throughout the year, the Steering Committee discussed how GFC would meet – online or in person. The GFC met online for all meetings, except for the April meeting.

### Academic Planning and Oversight Committee Responsibilities:

- Undergraduate Degree Review Workgroup (UDRW) GFC received monthly updates from the UDRW that was fulfilling Priority #1 in the Academic Plan: Advance Quality Sustainable Programming that Prepares Students for Life and Work Beyond Graduation. The two key strategies it focussed its work was in
- Strategy 1: Ensure reliable curricular quality and planning
- Strategy 2: Build on program quality assessment and review to develop innovative, in-demand program opportunities
   In May 2022, GFC approved a significant modification to the Bachelor of Fine Arts program.

### Annual presentation of the Draft AUArts Budget

The GFC annually reviews the draft budget and is entitled to make recommendations to the Board of Governors in academic and research areas. The GFC reviewed the budget in April 2022. There were no recommendations to the Board.

### Academic Policy Committee Responsibility:

### • Introduction of a Fall Break

The work was conducted by the Academic Policy Committee, and it was recommended that the addition of fall break would:

- coincide with Remembrance Day in November
- align the current term length of all the schools to minimum of 12 meeting instances
- o provide for the opportunity for a make up day at the end of term, if needed
- align the final assessment period for the four schools at the end of the term
  5 days and a Saturday

### President's Cabinet Responsibilities:

### • Draft Indigenous Framework/Strategy

A first draft was completed in June 2021 and the final Framework will be presented to APOC, GFC, and the Board of Governors (for endorsement), in due course. It was noted that more work needs to be done within the internal community. Currently Troy Patenaude is working with Elder Casey for the refinement of the AUArts Community outreach. The draft framework was presented to the Elders Council and Elder Casey identified opportunities for enrichment. The plan now provides five pillars: Relationships & Engagement, Administration, Training & development, Co-curricular Environment, and Curriculum & Teaching. The design of the final document will include indigenous student artwork. A focal point is Black Foot Tipi as representatives of the AUArts indigenous strategy and its relationship with the Lodgepole Centre.

### • Equity, Diversity, and Inclusion Taskforce

The Taskforce's primary purpose it to select and support the procurement of a consultant who knows the post secondary sector, has experience conducting EDI research and organizational planning. The consultant will gather information about our institution and with it develop a comprehensive EDI plan and recommendation.

The role of the taskforce is to provide outreach and engagement, providing feedback and suggestions to the consultant in support of their work. Ensure that the institution receives appropriate recommendations based on our current contexts. The consultant, Higher Education Strategy Associates (HESA), developed a three-prong strategy: quantitative research (survey), qualitative subjective component and public forum.



### • Sexual Violence Policy Review

The review is being completed by a work group, several of which are expert internal members who have worked with sexual violence on campus. The Advanced Education Ministry has asked for revised documents by November 2022.

### President's Cabinet Responsibilities:

### • Recovery Management Team (RMT) Updates

RMT has a continued priority focus on health and safety and the Vaccination Policy came into effect on November 15, 2021. 97% vaccination rate for all three groups at the university. Students who do not comply with the vaccination policy will receive a WR on their transcript. Public access was restricted and then removed in May 2022. Only courses that have been approved to be taught online will remain online in Fall 2021 and all other courses will be taught in person. RMT winding down in early spring.

### • 2002-2021 Annual Library Report

The library is committed to producing an annual report. The current report highlights programming, partnerships, new initiatives and collections, brief overview of circulation, reference metrics and other count data.

### Student Affairs Committee Responsibility:

#### Student Complaint Guide and Form

The form will give students clarity on the process for student complaints. The Form is posted on the student success centre and experience with the Guide and Form will be evaluated in a year.
